The CCRE program incorporates some of the most popular educational programs currently offered by IPU, including the Annual Regulatory Studies Program (affectionately known as "Camp NARUC"), the Advanced Regulatory Studies Program, the Grid School, and the NARUC Utility Rate School. For more experienced regulatory practitioners, research, teaching, and publishing opportunities are available for credit toward additional certificate levels.

Applicants may receive credit toward their CCRE as far back as 2008.
